

Member Documentation Requirements

All financial Kalbarri Visitor Centre members operating within Kalbarri and surrounding areas require certain licensing certificates to trade.

For the Visitor Centre to book and recommend your product, we are required to hold on file a current copy of each of the relevant documents that pertain to your business operations. These are compulsory requirements for every member upon annual renewal of membership and throughout the year when documents expire. Depending on what business you have, we always recommend the first place of contact is the Shire of Northampton for their guidance.

This checklist is a guide only, and all members should refer to relevant industry or government bodies for full information relevant to their business.
